Dear Mr. Groom:

Today I again visited your sites. They continue to contain inflammatory and libelous material which is clearly dedicated to the destruction of my personal reputation and that of Saint Stephen the Great/Saint Stephen the Great Charitable Trust. I wrote you yesterday to tell you how personally and profoundly appalled and devastated I am by what you have written about me, my brother, my family and these charities -- as well as by what you have encouraged and allowed to be posted on your various sites. I pointed out how particularly offensive and hurtful this is to me given Mr. Groom's last written communication to me, which ended "Assuring you of my prayers."

I renew my demand that you take this material off the internet. I remind you that, as I stated yesterday, I am a private individual. My personal privacy is important to me and you continue to invade it. I am not a public figure such that you have the right to drag my name and my family's names through the mire. I do not consent and object to you maintaining websites or portions of websites about me, SSG, SSGCT, ENC Management, my brother, my wife, or my daughter. I do not consent to you posting blogs about me on the internet. I do not consent to you defaming me to any other party or person by "sharing" your false allegations.

**Legal Demand**

I demand that you cease and desist from doing any of these things any more. I specifically demand that you deactivate your webpages, websites and/or blogsites devoted to me, my brother, my family, SSG and/or SSGCT IMMEDIATELY. These include:

But if that is your wish, I will not hesitate to seek the protection of the law. I also will take legal action against each of you for damages for libel.

I sincerely hope you will not force me to sue you. Just do the right thing and stop libeling me, my family and St. Stephen the Great. You have hurt us all enough and by now, you have gotten your agenda out. It is past time to stop.
